Acting local, supporting the practice standards which require Western Australians because of their distance from the east coast to be just that bit better. Board members have considerable fun together and enjoy the feeling of taking part in important Western Australian history.

We owe our interim Board a debt of gratitude and I mention Pattie Benjamin who has worked tirelessly, Greg Swensen for his commitment and uncanny ability with computers, the wisdom and counsel of Mary Joyce who has taken on the job of Treasurer and Brian Dodds our vice President who has worked with Barbara Meddin to establish the locum register.

I also mention Karen Vincent with her clarity of purpose and steely determination to make the conference a winner and her co-convenor Cindy Gorton whose systematic and methodical approach provided equilibrium and the practical efficiency of Erlene Chun. There was also the conference committee and the wonderful student volunteers.

Emma White has brought a fertile approach and a younger mind and Roma Lewi a lifetime of professional experience and wisdom, and the quiet determination to do things with care and precision.

Anne Pickard and Paddy Glasgow have provided calm and comfort when we sometimes wondered if the task was beyond us and have

acted in the CPE area despite each having sick elderly mothers, my own experience giving me insight into the commitment that entails.

Our inaugural conference was an unqualified success. The venue was welcoming and appropriate for a conference of such moment. The unselfish efforts of all involved enabled attendance costs to be affordable. It is an underlying and important principle for the SPSW that all costs will be kept to a minimum and profits made in WA used here for the betterment of the profession.

The CPE programs have been extraordinarily successful in content, attendance and fellowship. We are recovering the enthusiasm of the past and again experiencing rewarding satisfaction in hard won outcomes.

There is still a lot to do. The society will continue with a program of annual conferences, it will continue to invest in ongoing education, it will continue to offer support to individual members and it will continue to offer fellowship. The profession's future is in the hands of all of us.

It is important for us to work together with the AASW especially in those national and international areas which concern us in WA. Unfortunately some of our attempts have stalled. Early this year we met with the acting National President who requested we submit to her our ideas on how the rift can be turned into a positive thing. This we did soon afterwards but as yet there has been no reply. The SPSW has written to the WA Director of the AASW about our involvement in the matter of registration but there has been no formal response.

We are anxious to forge a memorandum of understanding with the AASW. It is difficult to move forward without a commitment by both groups to a clear set of shared objectives and an ongoing dialogue in particular concerning ethics, practice standards, registration, entry standards and professional identity.

It is my firm belief that the constituent members of both the AASW and the SPSW must maintain pressure on their respective organisations to achieve outcomes for the social work profession which are congruent with the profession's values, and sustainable.

Like any small business, our first year of operation has been characterised by a steep learning curve, while we have established financial protocols, built up banking relationships and developed general operating rules for management of the Society's financial accounts.

We chose to use Bendigo Bank as our service provider, in line with our theme of supporting those at a local community level. Their personal approach and local knowledge has been extremely helpful.

In broad terms however, we are very pleased with our achievements in our first year of operation, with a health account balance of \$7,577.32 at 30 June 2004. This has been achieved through an increasing membership base and a very successful conference.

We have acted to minimise costs so as not to burden members with unnecessary and costly infrastructure. Our main financial cost is the purchase of professional indemnity insurance for our members, the smaller fixed costs are related to our ISP for our website and GPO box office usage.

We have sought to provide discounted rates to all members at our functions and CPE events, only ensuring that our costs are met.

The year ahead will see us refine and streamline our financial processes particularly in relation to monthly membership fees.

I would particularly like to thank all the people who have volunteered hours of their time to develop our accounting processes. This includes Norma Welsh and Brian Wooller who did the initial set up work, Greg Swensen who maintains members details and provides the tax invoices and Pattie Benjamin who maintains the linkages between the bank, the SPSW and members.

sion with speakers. ■ PRACTICE IN HEALTH

The SPSW is rapidly building a strong base of members with practice interest in health related issues. The SPSW is represented on two significant bodies, which provide a voice for allied health professionals they are the Combined Health Professions Association (WA) and the Allied Health Peak Body Project Team.

The aim of the latter group is to establish an Allied Health Peak Body in WA, a recommendation from the Allied Health Task Force, which was completed in 2003.

The SPSW has been active in other roles – eg promoting patient access to inpatient mental health facilities. The SPSW lobbied in relation to the proposed closure of psychiatric units at Sir Charles Gairdner Hospital and Royal Perth Hospital. The Government has now reviewed this decision and it will not proceed in the foreseeable future.

The SPSW has written to Mr Tony Abbot, Federal Health Minister, regarding the new Enhanced Primary Care Program, under Medicare for allied health services. The SPSW is lobbying for members in the mental health area to obtain a registration number from the Health Insurance Commission in order to access the Medicare rebate and receive referrals from general practitioners. It also requested Mr Abbot to endorse social work as a stand alone profession across all health areas, particularly the aged sector and not just be confined under the general heading of mental health worker.

In August the SPSW met with Ms Julie Bishop, Federal Minister for Ageing in regard to addressing the members on her vision for aged care. As noted in the CPE report plans are underway to reschedule this event.

The SPSW has also written to Dr Neale Fong (responsible for implementing the 2003 Reid Report for WA health) requesting the actioning of Recommendation No 57 of that report. This is to establish a senior allied health position in the Department of Health. We eagerly await the outcome.

At the SPSW conference in May 2004 a group of social workers interested in the issues and practice of social workers in health met to discuss areas of interest and a future interest group.

From this group, Carolyne Wood a senior social worker at Sir Charles Gardiner Hospital has taken the position of chair and is keen to hear from members with issues and ideas of how to further promote social work practice in health.
